DMC0-SPO2020/1110 dated: 12.11.2020, State Government has granted permission to resume skill training in Training Centre under Haryana Skill Development Mission and Shri Vishwakarma Skill University, Haryana (SVSU) in the state of Haryana.

Therefore it is hereby directed to open all the Training Centre **(except those where residential trainings are being provided)** under Haryana Skill Development Mission and Shri Vishwakarma Skill University, Haryana (SVSU) for skill training with effect from the date of issue of this order by doing staggering of the trainees for maintaining social distancing following prescribed SOPs and Guidelines issued by MHA, SDMA, DGT and local Administration time to time,.

Precautionary measures to be enforced:

- Attendance of trainees will not be enforced and trainees will be allowed to come to the training center for skill training only with prior consent of their parents.
- Provision of thermal scanning and pulse oximeter at each institute to detect the suspected cases suffering from COVID-19.
- Ensuring availability of sanitizers, multiple drinking water points and clear washrooms in the institute.
- Regular sanitization of workshop, laboratory, classrooms and frequently touched surfaces like door handles.
- Separate gate for entry and exit for the trainees.
- Ensuring ventilations in classrooms and workshops.
- COVID-19 test of all faculty before the start of the training in the institutions.
- Directing all trainees and staff to bring mask, sanitizer bottle, drinking water bottles and lunch from their name.
- Mandating the wearing of mask all the time by the trainees and staff.
- Intimating local administration and health authorities in case COVID-19 suspected cases are identified in the institute.
