The program includes the knowledge, understanding and skills required of an EMT to respond to a call received from the Dispatch and prepare to move to the emergency site and the skills required of an EMT to decide on action to be taken upon arrival at the emergency scene to evaluate the situation and ensure the safety of patient(s) and others. It also covers standardised procedures to be followed and acceptable standards of care required of an EMT. It also includes permissible and appropriate emergency medical service procedures that may be rendered by EMT for patients while on a call. It also includes skills required of an EMT to recognise and treat emergencies related to the cardiovascular system. It also describes the knowledge, understanding and skills required of an EMT for the recognition and treatment of emergencies related to Poisoning or Overdose. It also covers the knowledge, understanding and skills required of an EMT to deal with bleeding and shock (hypo perfusion) as identified during the initial patient assessment after securing the scene and ensuring personal safety. This program includes bathing a patient by General Duty Assistant. It also covers dressing, feeding a patient by General Duty Assistant. It also covers transferring a patient by General Duty Assistant. It will also focus on Infection control as it is an integral part of clinical care which focuses on preventing spread of microorganisms while performing different patient care procedures. During the course, the individual will also get training on implementing simple procedures like enema or preparing the patient for an operation, that need to be performed by the General Duty Assistant, making observations and reporting changes in patient's condition. It also covers taking appropriate measurements. The knowledge and skill of Measurement of weight and height, Promptly responding to call bells, cleaning of medical equipment transporting patient samples, drugs, patient documentation (patient files, discharge summary etc.), changing/ transporting/ managing laundry/ linen on the floor, carrying out the last office i.e. providing death care to the deceased person is also included in the course. It also covers knowledge, understanding, skills required of an Allied Health Professional to monitor the working environment, and making sure it meets health, safety and security requirements, knowledge, understanding and skills required of an Allied Health professional to practice code of conduct setup by the healthcare provider, knowledge, understanding and skills required of an Allied Health professional to manage biomedical waste. This program is designed for NSQF Level 4.
