

Contractor Saksham Yuva Scheme

An initiative of Haryana Govt. named “Contractor Saksham Yuva Scheme” in which Skill Training will be imparted to train & up-skill 10,000 youths having Diploma or Degree qualification in Engineering so that they can unlock new career opportunities in the field of Engineering for their professional development leading to better entrepreneur avenues and enabling them to work as works contractor.

➤ **Objectives:**

- Recognition of talent and supporting with financial assistance from Govt.
- Actively promoting self-employment and entrepreneurship, creating an ecosystem that empowers individuals to pursue their business aspirations and contribute to the economic development by providing employment opportunities for others also.
- To formulate a coherent but flexible policy for providing self-employment and skill development opportunities for the youth in the State of Haryana.

➤ **Eligibility:** In this scheme, every candidate whose age is between 18 to 40 years having B.E/ B.Tech/ Diploma in Engineering, PPP ID & qualified in merit list of Common Entrance Test (CET) held by Haryana Govt. for Group ‘C’&‘D’ Jobs is eligible to avail the benefits of scheme.

➤ **Implementation Strategy:**

- A three months training will be imparted which will be consisting of theoretical as well as on job training with Govt. Departments which will enable them to work as a contractor.
- SVSU will be the training partner and shall further decide the training batch creation and selection of training center in consultation with the SDIT Department.
- During training period, the youth need to ensure that they must obtain PAN, TAN, GST, TIN etc. for their firm which will be registered on Haryana Engineering Works portal.
- The trained & certified youth will be empaneled with Haryana Engineering Works portal for which all necessary requirements will be completed by candidate themselves.
- Govt. will extend the facility of interest free bank loan of upto Rs. 3.00 lakh to these trained certified youths for 1 year. Trained youth under this program will be able to take contract for work up to Rs. 25 lakhs.

➤ **Financial Implication:** of Contractor Saksham Yuva Scheme will be Rs. 66.88 Cr.
