PART II: DEFINITIONS

In this document, the following terms shall have respective meanings as indicated:

- i. "Applicable Law" means the laws, rules or regulations and any other instruments, having the force of law in Republic of India, as in force from time to time.

4.1 Eligibility/Pre-Qualification criteria

The bidder qualifying the following criteria shall be considered eligible to bid for this RFP. The Proposals of the Bidders shall be evaluated for meeting the eligibility/prequalification criteria based on the parameters listed below:

4.2 Examination and Evaluation of Bids

- a) Opening of Bids will be done through online process only.
- b) HSDM shall open Technical Bids as per the schedule specified in Key Dates, in the presence of the authorized representatives of the Bidders, who choose to attend. HSDM will examine and evaluate the Bids in accordance with the provisions of this RFP.
- c) During evaluation and comparison of bids, HSDM may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given in writing via email, asking the Bidder to respond by a specified date, and also mentioning therein that, if the Bidder does not comply or respond by the date, his tender will be liable to be rejected. No post bid clarification at the initiative of the bidder shall be entertained. The shortfall information/ documents shall be sought only in the case of historical documents which pre-existed at the time of the bid opening and which have not undergone change since

then. Evaluation Process:

- The Technical Bids will be evaluated by an Evaluation Committee. The Bidder shall have to fulfil all the Eligibility Criteria as specified in the RFP. The following documents shall be evaluated as per part of Pre-Qualification stage: - Bid Security Declaration Form and other Eligibility Documents and Annexures.
- The Bidder shall have to submit all the required documents as per various formats provided in Annexures. These documents will be scrutinized in this phase of ii. evaluation. Those Bidders who do not fulfil the terms and conditions of Eligibility Criteria as specified in this tender will not be eligible for further evaluation.
- The Bidder shall have to submit all the required documents as per various formats provided in Annexures. These documents will be scrutinized in first phase of iii. evaluation. Those Bidders who do not fulfil the terms and conditions of eligibility criteria will not be considered eligible for further evaluation and shall be declared as non-responsive.
- d) Financial bid of only responsive bidders shall be evaluated.
- e) If a firm quotes NIL charges / consideration, the bid shall be treated as unresponsive and will not be considered.
- f) The bidder with lowest Total Cost (L1) as mentioned in the Financial Proposal Annexure-VI will be treated as the preferred bidder.
- g) The bid price will include all taxes and levies except GST and shall be in Indian Rupees.

4.3 Miscellaneous

- a) The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Chandigarh shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- b) HSDM, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to;
 - suspend and/ or cancel the Bidding Process and/ or amend and/ or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto;
 - ii. consult with any Bidder in order to receive clarification or further information;
 - iii. retain any information and/ or evidence submitted to HSDM by, on behalf of, and/ or in relation to any Bidder; and/ or
 - iv. independently verify, disqualify, reject and/ or accept any or all submissions or other information and/ or evidence submitted by or on behalf of any Bidder.
 - c) It shall be deemed that by submitting the Bid, the Bidder agrees and releases HSDM, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder, pursuant hereto and/ or in connection with the Bidding Process and waives, to the fullest extent permitted by applicable laws, any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or in future.

4.4 Earnest Money Deposit (EMD): -

- 4.1 The bidder shall furnish, as part of the bid, Earnest money Deposit (EMD of an amount of Rs. 20,000/- on etenders.hry.nic.in. which is refundable without interest, if not selected. If selected, the same can be adjusted with the performance security deposit's (PSD) amount.
- 4.2 EMD of unsuccessful bidder will be refunded within 30 days after issue of LOA to successful bidder and EMD amount of successful bidder would be refunded after submission of performance security.
- 4.3 The Earnest Money will be forfeited.
 - (i) If the bidder withdraws the bid after its submission;
 - (ii) If the bidder does not accept the correction of the bid required by Authority; or
 - (iii) In case of a successful bidder, if the bidder fails to produce the requisite document, sign the Contract Agreement and supply the vehicle, within time specified in the 'Letter of Acceptance (LOA).

4.4 Performance Security: -

The successful bidder will be required to submit the performance security for an amount of 6.5% of awarded cost for 24 months in the form of DD payable to Haryana Skill Development Mission "payable at Panchkula within 7 days of issue of letter of acceptance (LOA). The performance security shall be refunded after successful completion of the contract.

6. Bid Validity: -

The bid shall be valid for 180 days from the date of opening as prescribed in 3.6 above.

7. Award and signing of Contract: -

HSDM will award the work by issuance of LOA to the successful bidder whose proposal has been determined to be substantially responsive and has quoted the Lowest Cost as per the process outlined above. The bidder shall then within 7 days submit performance security and non-judicial stamp paper of Rs.100/- for signing of contract agreement with HSDM.

8. Right to vary quantities: -

HSDM reserves the right at the time of award of contract to increase or decrease the number of vehicles as per required quantity of services specified in the schedule of requirements without any change in hiring of the offered rates and other terms and conditions.

09. Right to reject any or all the bids:-

HSDM reserves right to reject any or all the bids without assigning any reason and no claim of whatsoever nature will be entertained for such act.

10. Pre bid Meeting:-

Pre bid meeting of all the interested bidders will be scheduled at Haryana Skill Development Mission, Kaushal Bhawan, Ip-2, Sector-3, Panchkula-134109.

Part- V (TERMS & CONDITIONS)

- The bidder should have valid registration in RTO/GST on the date of submission of Bid.
- The work includes provision of vehicle conforming to RTA/RTO regulation along with fuel, driver, and maintenance etc. for office use and site visit for the purpose of monitoring the projects and related works.
- 3. The Bidder shall submit proof of ownership/lease of at least 4 similar vehicles.
- 4. Copy of lease agreement between bidder & owner of vehicle with proper proof of identity of owner (on Rs.100/- stamp paper), in case any vehicle not owned by the bidder, must be attached, otherwise bid shall be treated as non- responsive and shall be rejected.
- 5. The Vehicle shall be insured from any valid Insurance Company. The insurance shall be kept valid by the bidder (at his own cost) during entire contract period.
- 6. HSDM will not be responsible to compensate for any damages occurred (if any) due to accident to the vehicle or any person/ property / driver during duty hours. The entire liability of accident shall be borne by the bidder.
- 7. The bidder are advised to quote the vehicle rate including all necessary cost towards maintenance of vehicles, salary of driver, fuel & lubricant for vehicles, interior decoration of the vehicle, RTO / State Govt. Taxes and other taxes, if any, weekly holidays to driver etc. excluding GST & Toll Tax. TDS (Income Tax) & GST TDS will be deducted from the payment of bill as per applicable rules.
- 8. Monthly Payment terms and condition: -

The vehicle to be supplied shall be in good condition & should be not older than 2022 model. The vehicle shall be provided 10 hours per day for 6 day's basis depending upon requirement of HSDM.	The firm / agency / individual should submit their bills along with logbook within 1st week of every month for payment. It is the responsibility of the firm / agency / individual to maintain the log book of vehicle and get it certified from the concerned officer/official using the vehicle, failing which, payment shall not be released. 100% payment shall be released within 15 days from the date of submission of valid invoice and all supporting documents along with proof of GST deposit.

- 9. The vehicle shall be provided for 10 hours per day during Duty Hours basis depending upon requirement of HSDM.
- 10. The vehicle should be a petrol model.
- 11. The number of vehicles to be engaged by HSDM may be increased or decreased on the discretion of HSDM. The additional fuel cost will be compensated by the Mission, if the increase is more than 5% of the current rate as applicable on today.

- 12. Drivers must have valid driving license, mobile phone, neatly dressed in a defined dress code approved by HSDM, well trained, well behaved, physically / medically fit and with experience of more than 05 years running on Highways. Any cost whatsoever incurred on account of this is deemed to be included in the quoted rates. If necessary, successful bidder shall also provide additional / replacement driver, as and when called by HSDM, failing which HSDM shall levy penalty of Rs. 1,000/- per day.
- 13. In case of non-availability of vehicle, HSDM shall levy penalty of Rs. 1,000/- per day which will be over and above the per day rate.
- 14. In case of maintenance / off road / breakdown of vehicles, a suitable replacement of the vehicles shall be provided within two hours. If firm / agency/ individual fails to provide replacement of vehicles, a penalty of Rs.200/- per hour of delay on each occasion, if the reason of late arrival is unsatisfactory <u>plus actual hiring charges of vehicle</u> shall be recovered from the bills/performance security of firm / agency/ individual.
- 15. The selected bidder shall park the vehicle in the premise of HSDM or as desired by the HSDM officials. The vehicle should not be used by the successful bidder/ driver for their own/ any other commercial purpose.
- 16. The vehicles are to be used for travelling under the jurisdiction of HSDM and to other places, as required.
- 17. The bidder must quote the rates both in words and figures for all categories of vehicle. In case there is a difference between the quoted rate in words and figures, rates quoted in words shall prevail. If no rate is quoted for a particular type of vehicle's, then the bid shall be considered as non-responsive bid.
- 18. The firm / agency / individual should submit their bills along with logbook within 1st week of every month for payment. It is the responsibility of the firm / agency / individual to maintain the log book of every vehicle and get it certified from the concerned officer/official using the vehicle, failing which, payment shall not be released.
- 19. Successful firm / agency / individual shall have to supply the required vehicle within 15 days from the date of issue of Letter of Acceptance by HSDM.
- 20. Evaluation of bid shall be done for award of work on the lowest cost basis.
- 21. The successful bidder/bidder shall submit all the required documents of vehicle, Insurance, GST Registration Certificate etc. to execute agreement with HSDM as per terms & conditions mentioned in the bid document, on non-judicial stamp paper of Rs. 100/ which will be made available by the successful bidder, failing which 2nd lowest bidder will be given offer.
- 22. The agreement will be made with the selected bidder for a period till 31st March 2025 as per

- terms & conditions mentioned in the bid document and rates accepted by HSDM. The agreement may be extended beyond said period on the direction of HSDM depending upon performance of selected bidder and on recommendation of the concerned official.
- 23. If successful bidder fails to provide specified vehicle(s), Authority shall have the right to forfeit the Earnest Money / BID Security submitted by the successful bidder.
- 24. The contract agreement may be terminated either HSDM or successful bidder at any time serving one month's advance notice in writing, against which no compensation shall be paid to bidder.
- 25. The bids received after due date / time shall summarily rejected.
- 26. Amendments, corrigendum, if any, would be hosted on HSDM website only.
- 27. HSDM reserves full rights to curtail / modify, halt / cancel, reject any or all offer/s, at any stage without assigning any reasons and no claim of whatsoever nature will be entertained on this account.
- 28. The successful bidder should ensure that sufficient fuel is always available for travel.
- 29. The successful bidder should quote their rates on monthly basis i.e. per vehicle per month.
- 30. Extra running of vehicle above monthly limit of 2500 km per month will be calculated at the end of 31st March 2025 and running distance of all the months will be calculated. If its found that there is extra running, then it will be calculated as Rs 20 per km.
- 31. The initial period of engagement shall be till 31st March 2025. The period of engagement may be further extendable by additional 1 year at the sole discretion of HSDM.
- 32. HSDM will not have obligation: -
- (a) HSDM shall not be liable for payment of wages/salaries, other benefits and allowances to his personnel that might become applicable under any act or order of the Government. In this regard, and the service provider shall indemnify HSDM against any / all claims which may arise under the provisions of various acts, government orders etc. And any breach of such laws or regulations shall be deemed to be breach of this contract.
- (b) No direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC shall be borne by HSDM, and any loss caused to HSDM have to be suitably compensated by successful bidder.
- (c) HSDM shall not be responsible for theft, burglary, fire or any mischievous deeds vendors staff.
- (d) The successful bidder shall be the employer of his workers and HSDM will not be held responsible fully or partially for any dispute that may arise between the successful bidder and his workers.
